

## Consent for image, identification & lifestyle data recording

In the recording framework of:

- **15 – 18 September 2026**

■ I give my consent to the *Université de Lorraine (UL) / department of Usages du Numérique* for the collection, recording, organization, storage, use, communication and broadcast, in the respect of my image and private life, the following information about myself :

- Identification data : Surname, First name
- Professional and educational data : diplomas, educational status, position
- Image and sound of my person recorded by video films by the UL (or a third party on its behalf),

■ I give my consent for these personal data to be used for the following :

- Royalty-free copy by provisioning the Université de Lorraine's web pages.

The length of data retention for images and personal data is 30 years.

The image of my person in the video recording, as well as any data that may enable to directly or indirectly identify me, are personal data about myself.

■ For this reason, I am informed that, according to the provisions of the *Règlement général sur la protection des données N°2016/679 (RGPD)* and the *Law 78-17 modifiée relative à l'informatique, aux fichiers et aux libertés*, I have a right of access, rectification, deletion, limitation and portability of the data regarding my person.

More specifically, regarding the electronic distribution, the University commits to communicate my expressed requests in application of the above law to the Director of publication of the sites in question. However, the University cannot coerce this authority, if it is external, to fulfil these requests.
